**Terms and Conditions :**

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates must have registered their names in the Employment Exchange and the Registration is to be valid as on date of submission of applications.
3. Candidates must have passed Class VIII and those who have passed Class XII and above shall not be eligible for the post.
4. Candidates must not be less than 18 years or more than 38 years of age on 01-06-2020. The upper age is relaxable as per Govt. norms.
5. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card along with 3 (three) copies of recent passport size photographs duly

- signed by the candidate on the reverse side should reach the Office of the District and Sessions Judge, Sonitpur, Tezpur.
6. The applicant for the post of Driver must have a valid Professional/Transport Driving Licence along with experience certificate for more than 3 years. Further, a character certificate is to be enclosed.
